

## RELEASE AND WAIVER

The undersigned on my behalf and on behalf of my heirs, personal representatives, executors, successors and assigns), for and in consideration of the opportunity to engage on Saturday, May 8, 2010 in the **1st Annual Charity Poker Ride** (the "Event") and for other valuable consideration, the receipt and adequacy of which are hereby acknowledged, releases and forever discharges the officers, directors, shareholders, employees, agents, representatives of **Cass High School, The Blue Ridge Chapter Nam Knights America MC Inc. and the American Legion** from all liability, including any and all claims, demands, rights and causes of action of any kind whatsoever, known and unknown, whether caused by the negligence of the released parties or otherwise, which I now have or later may have in any way resulting from, or arising out of, directly or indirectly, my participation in the event.

This release extends to any and all claims I have or may have against the released parties, even if such claims result from product liability, strict liability or negligence (except willful negligence) on the part of any or all of the released parties concerning the design, manufacture, repair or maintenance of any motorcycle which I will be riding, or concerning the conditions, qualifications, instructions, rules, procedures or conduct under which the Event is constructed, or from any other cause. I understand this to mean that I agree not to sue and waive my right to sue any and all released parties for any injuries resulting to me or to my property during the conduct or, or in connection with the Event and that the released parties shall not be liable for any and all claims for loss, damage or injury of any nature whatsoever to person or property whether caused by the negligent acts of any or all of the released parties or otherwise. However, I do NOT release any party from any claims for intentional misconduct on its part.

I hereby state I am at least eighteen (18) years of age and that I am experienced in and familiar with the operation of various motorcycles. I fully understand the risks and dangers inherent in motorcycling and that the activities of the Event and motorcycling involve the risk of serious bodily injury and/or death. I am licensed to operate a motorcycle. I am voluntarily participating in the Event and I expressly agree to assume the entire risk of any accident or personal injury, including death, which I might suffer as a result of my participating in the Event due to the negligence of the released parties or otherwise. I am in excellent physical and mental health and know of no health-related reason why I cannot fully and safely participate in the Event. I participate in the Event knowing the existing weather conditions, road conditions, and other similar conditions, factors and circumstances associated with the Event may vary and such variance may give rise to any injuries, which I may sustain.

By signing this release, I certify that I have read this release and fully understand it and that I am not relying on any statements or representations of anyone released thereby. I further understand and expressly agree that the foregoing Release and Waiver is intended to be as broad and inclusive as is permitted by the laws of Georgia and that, if any portion of the Release and Waiver is held invalid, it is agreed that, notwithstanding the invalidity of that portion, the balance of the Release and Waiver shall continue in full legal force and effect.
